It is roughly circular, with a "tail" (Sekotong Peninsula) to the southwest, about 70 kilometers (43 miles) across and a total area of about 4,514 square kilometers (1,743 square miles). The provincial capital and largest city on the island is Mataram. It is somewhat similar in size and density with neighboring Bali and shares some cultural heritage, but is administratively part of Nusa Tenggara Barat along with sparsely populated Sumbawa.


